2. All prices quoted to Purchaser are subject to change without notice, unless otherwise stated.
3. All payments on accounts must be made within the discount period stated on each invoice in order to earn any discount offered by Sellers.
4. A service charge of 1.5% per month will be charged on all past due balances for purchases prior to and after judgment. Waiver of any one default shall not be deemed a waiver on other default or breach by purchaser.
5. Terms or conditions on any purchase order or other form issued by Purchaser which are in addition to, modify, or are inconsistent with Sellers' Terms and Conditions will not be binding on a Seller unless agreed to in a separate writing executed by an officer of the Seller.
6. This agreement is governed by the laws of the State of Arizona and jurisdiction for any suit or related action shall be conducted in Maricopa County. Purchaser shall pay all costs and expenses incurred by Seller, including attorney's fees, in collecting any monies due from Purchaser to Sellers, whether or not suit is filed.
7. Goods purchased are warranted and guaranteed only to the extent and in the manner guaranteed to Seller by the original manufacturer of such goods. All warranty claims shall be made by Purchaser directly to the manufacturer in accordance with the manufacturer's warranty. All transferable warranties made to Sellers by the manufacturer of the goods shall be made available to Purchaser. **SELLERS MAKE NO WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, AND ALL WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY DISCLAIMED.** Sellers' liability shall be limited to either the replacement of goods or a refund of the purchase price and in no case shall Sellers be liable for incidental, consequential or liquidated damages.
